The Government makes no statement, representation or warranty (express or implied) to the Non-Government Organizations / Social Enterprises that the Notifications or any of them will be uninterrupted, timely, secure, or error free. The Non-Government Organisations / Social Enterprises should read the tender/ quotation notices published on the website of GPA from time to time for the latest information.
